An initial SB 19-181 Objective Criteria of Highpoint Operating's Fox Creek 25 SE location that is to be located in section 25, Township 12 North, Range 63 West, in Weld County has been completed. The review was triggered by the location falling within the boundary of the Upper Crow Creek Designated Basin making the Fox Creek 25 SE location a sensitive area by rule. Due to the location being in a sensitive area for groundwater the following COA will applied to the 2A document # 401905333:

The location is in a sensitive area because it falls within the boundary of the Upper Crow Creek Designated Basin, therefore, the operator shall line the secondary containment areas for the tanks and separators with an impervious material to prevent the downward migration of produced liquids.
