### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

During third-party construction activities within the area of the plugged and abandoned Champlin 32-14 #2 well, methane was detected in the subsurface. The volume of the methane release is unknown. The cause of the methane release is currently under investigation.

### PROPOSED SAMPLING PLAN

Assessment activities completed to date include a surface assessment using a methane flux meter at 122 locations around the plugged and abandoned Champlin 32-14 #2 well, a shallow surface assessment by installing and screening 79 hand augured borings to five feet below ground surface, and installation of 68 soil vapor points from 12 to 47 feet below ground surface to determine the source and extent of methane. The horizontal extent of the subsurface methane plume is not defined, and assessment is ongoing.
