On 10/24/2019, Catherine Roy conducted a reclamation and stormwater inspection. During this inspection the following compliance issues were observed:

Comment Approximately 3000 Russian knapweeds observed within the northern and southern portions of the project area. Knapweed infestation, first documented in 2015, continues to expand within the project area.

Corrective Action Weed infestation needs to be controlled immediately. Corrective action is backdated to previous corrective action date to document duration of non-compliance for potential enforcement. Areas treated for weed infestation will need to be monitored and revegetated/stabilized after treatment. Monitoring data may be requested.
