Comments:

The former FLOYD ADLER GAS UNIT B1 well (API: 05-123-08348) was P&A'd on November 3, 2014 according to Form 6 Document Number 400727458. On August 19, 2019, LTE conducted a final reclamation inspection for the former FLOYD ADLER GAS UNIT B1 well pad (Location ID: 318077). The former well pad has successfully been returned to agricultural use. The inspection determined that final reclamation has been achieved in compliance with COGCC Rule 1004, which applies to reclamation of agricultural lands. The associated active tank battery is located adjacent to the well pad and remains in use servicing Kerr-McGee producing wells: API: 05-123-30454, API: 05-123-30370 and API: 05-123-30371. LTE personnel located the P&A wellhead location using a handheld Trimble (R1) Global Positioning System (GPS) unit and latitude and longitude coordinates obtained from the COGCC online database. Photographs of the P&A location were taken facing each cardinal direction from the P&A wellhead location.
