While there, I observed a shut in facility. During this inspection the following possible compliance issues were observed: 1. Unused equipment near wellheads/tank battery. PLEASE REMOVE EQUIPMENT TO COMPLY WITH RULE 603.F. (Corrective Action Date: January 5, 2019) See attached photos #4, 9-10, 16-17. 2. No signage at wellhead to indicate well name/operator. INSTALL SIGN TO COMPLY WITH RULE 210.D. (Corrective Action Date: January 5, 2019) See attached photo #6. 3. No containment device surrounding maintenance tank, inadequate berm surrounding tank battery. REPAIR OR INSTALL BERMS OR OTHER SECONDARY CONTAINMENT DEVICES PER RULE 605.A.(4).
