TO ALL INTERESTED PERSONS AND TO WHOM IT MAY CONCERN:

On August 16, 1982, the Commission authorized Order No. 338-1 to be issued which established 640-acre drilling and spacing units for the production of gas and associated hydrocarbons from the Middle Morrow Sand underlying all of Sections 21, 22, 27 and 28, Township 19 South, Range 47 West, 6th P.M. Specific permitted well locations were designated for each unit.

On July 30, 1985, J.W. Gibson and Burton/Hawke, Inc., by their attorney, filed with the Commission a verified application, which was amended on August 19, 1985, for an order extending the limits of the spaced area as established by Order No. 388-1 to include the following described lands in Kiowa County, Colorado, to-wit:

Township 19 South, Range 47 West, 6th P.M.

Section 15: All
Section 16: All
Section 17: All

Section 20: All
Section 28: All

and further that the permitted well location be at any location in each unit as long as it is no closer than 5,000 feet from another well producing from the Middle Morrow Sand.

Pursuant to said hearing in the above-entitled matter at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to prevent the waste of oil and gas, either or both, in the operations of said field, and to carry out the purposes of the statute.

Any interested party desiring to protest the granting of the application should file with the Commission a written protest no later than September 11, 1985, briefly stating the basis of the protest, and such interested party shall, at the same time, serve or mail a copy of the protest to the person filing the application.
