The following compliance issues were resolved:

- 1) Bolt holes in tank secondary containment.
- 2) Missing bird protection on 1 crude tank.

Additional compliance issues:

- 1) Northern most water tank is venting gas out on top of tank. Photo 5. Complete by 2-21-2020.

Note: Field specialist contacted about the gas venting on the day of this inspection.

A follow up inspection will occur to ensure the compliance issues have been corrected to comply with COGCC rules.
