Operator Comment: The CA to remove pipe material and other non-operating equipment from 2017 is not accurate. Please see FIRR 401461997 submitted with pictures on 11/21/2017 and COGCC inspections from 2018 and 2019. This equipment was removed after down hole maintenance. Please refer to the May 2019 MIT Form 42 - this represents recent work where this equipment was needed. It has been removed. Please be aware of downhole operations prior to creating an incorrect CA. A Factual Review Request was not allowed due to the COGCC time clock being inaccurate. Midnight is NOT a realistic timeframe.

Operator Comment: Netting was placed over the well cellar to prevent mice from entering. However, due to the warm buildings on the location, mice are attracted to them, so SG does set mouse traps at this location. Therefore, wildlife mortality will continue in the mouse traps.

Corrective Action: Stormwater controls need to be installed along the access using good engineering practices such as those described in CDOT manuals for erosion and stormwater control. Erosion along the access road needs to be stabilized.

Operator Comment: The access road has been maintained with good engineering practices. This region had a few large snowmelt events in which the SW control measures functioned as designed. Good thing they were installed! They are now ready for the next storm.
