General Comment:

OWP Assistance - Area-Landowner expressed concern to F.I. Schure during previous FIR regarding debris/trash laying on surface of road shoulder/borrow ditch along Logan County Road 25, adjacent to and accessing areas of work currently being performed by COGCC OWP. Extent of debris/trash extending for approximately (1/4) one-quarter of a mile along roadway. Origin of debris unknown/unidentifiable, consistent with metal sheathing/siding from oil & gas abandoned structures in the area.

Stakeholder was asked to file a formal complaint with COGCC however he declined, but requested that the debris be removed regardless. OWP determined it is in the best interest of cooperation with local stakeholders for OWP to authorize collection and removal of debris. Debris and trash collection and removal has been performed. Area referenced is currently clear of debris/trash along Logan County Road 25. via physical site visit documenting observations.

This FIR is using API # 05-075-06347 CM Production LLC Mount Hope-Green 31 OWP for purposes of this FIR, being the closest well location to the debris, but not identifiable as originating from that well-site.
