**General Comment:**

On 3/16/2020 Catherine Roy conducted a reclamation and stormwater inspection. Location is a shared well pad with BP America and Logos Production. It is the responsibility of the two operators to coordinate reclamation and stormwater maintenance activities. During this inspection the following compliance issues were observed:

- Remove junk and debris within the northwestern project area. Corrective action is backdated to 11/1/2018.
- Bare soils on the well pad fill slopes need stabilization by 4/17/2020.

Comment: Stormwater BMPs within the project area are largely full of sediment and not functioning. Bare soils on the well pad fill slope are eroding.

Corrective Action: Stormwater controls (ie BMPs) need to be repaired/replaced as needed. Erosion controls (ie: revegetation, mulching, blankets) are needed on bare soils on the well pad fill slopes.
