Reason for TA & 2019 details: In January 2019 the well was TA'd pending additional analysis. The well was also used to gather a bottom hole pressure survey as part of the Rangely Weber pressure monitoring program. Future plans for this well will be to work over and returned to injection in 2020. The casing in this well is isolated from the production zone with two packers and tubing. The well is isolated with a tubing plug set in the On/Off tool @ 5994' and closed valves on the wellhead. This well is economically viable in the current environment and is being worked over in order to return the well to service. The last witnessed and approved MIT was conducted on 1/25/2019.
