Most recent application for weed control photo documentation attach from the 3/31/20 application. Documentation of treatment provided from contract company on chemical application can be provided upon request. Corrective action has been addressed and attempts to control weeds is being performed on an annual basis. Eradication of weeds on locations is an extended process as seed beds and Knapweed viability can take 3+ years to gain control. BPX has plans to continue annual weed treatment programs performing efforts to address weeds
