Comment:

This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 11/13/2018.

Operator has failed to perform all reclamation activities. Annual, weedy vegetation, consisting mostly of tumbleweeds, was observed throughout the well and battery location. Refer to the attached inspection photos.

Tumbleweed (Kochia and Russian thistle) is a troublesome annual non-native weed that easily breaks off at the stem and becomes a tumbleweed spreading weed seeds. Operator has failed to prevent the spread of seeds onto adjacent lands.

Corrective Action:

Comply with Rule 1004 to perform all reclamation activities. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including weed management.

Corrective action date is being backdated to when all reclamation activities should have been completed.
