The western and southern berm was paid for and constructed by the Tierra Piedra Ranch, LLC in 2016 for aesthetics and is managed by Tierra Piedra Ranch, LLC personnel. Consequently, this area was also sprayed by Tierra Piedra Ranch, LLC personnel on 5/14/20 and 5/15/20.

Operator Comment: The North and part of the East berm were recontoured and seeded on 5/21/20. Erosion mats were placed on these areas on 5/22/20 to mitigate stormwater erosional effects. The majority of the East berm, the ~65' of Southern berm managed by Petrox was left because natural vegetation is progressing. These bermed areas were spot sprayed on 5/14/20 for intermittent weed. The rest of the Southern berm and Western Berm were paid for, built by, and are managed by Tierra Piedra Ranch, LLC (as built drawing on file with the COGCC and reattached to this FIRR).
