Comment: This location does not comply with Rule 1004. It has been nearly six years since the well was plugged and little to no establishment of desirable plant species were observed. There was some successful germination of smooth brome but much of the access road and well location were bare.

Corrective Action:

Date **11/16/2020**

Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.

Revegetation activities shall be complete no later than 11/15/20 or as soon as environmental conditions will permit.
