On Wednesday, June 3, 2020 at approximately 13:15, I, Inspector Brittani Santistevan, conducted an on-site inspection at RUMSEY 35-15 (Noble Energy), at location #: 329282 in WELD COUNTY Colorado.

While there, I observed a plugged and abandoned wellhead.

During this inspection the following possible compliance issues were observed:

1. All productive equipment has been removed from tank battery EXCEPT the gas meter. REMOVE TO COMPLY WITH RULE 603.F. (Corrective Action Date: September 3, 2020)

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
