No fluids or gas migration was present prior to cement plug to surface being set. Casing was cut at 750'. The plug was cemented to surface with 341 sacks of cement from 855'.

At the time of submitting of this form, flowlines have not been abandoned. Flowlines will be abandoned, with work starting on 3/30/2020. Form 42 Pre Abandonment Notice was submitted via Doc #402326930.
