Comment:	<p>In order to allow Operator the opportunity to separately address corrective action within a Resolution Form, the corrective action regarding 1003.f noxious weed management is being addressed within the "Good Housekeeping" section of this report.</p> <p>Previous inspection observed noxious weeds (Musk thistle) within the current interim areas of the Location. Inspection required Operator to conduct weed management by 5/27/2020. Operator submitted FIRR #402413689 stating "Weeds were treated, and will be re-monitored later in the year".</p> <p>It was observed in this inspection that weed management activities per the CA are evident. However ongoing management appears insufficient; Viable musk thistle plants/rosettes remain evident within interim areas.</p>
