Operator Comment: Rule 204 states that COGCC has "... the right at all reasonable times to go upon and inspect any oil or gas property." The reclaimed road leading to the well heads do not prevent or exclude COGCC from entering upon or inspecting any of the equipment at this location. The current access road is well maintained and allows access to the well heads by parking at the separators and walking a short distance (approximately 60 paces) to the north. There is nothing in Rule 204 that requires the operator to open a reclaimed road that is not needed.
