A cement bond log with gamma-ray will be run on the production casing (or intermediate casing if production liner is run). The horizontal portion of the wellbore will be logged with a measured-while-drilling log with gamma-ray. The Form 5, Completion Report, for this well will list all logs run and have those logs attached. The Form 5 shall state "Open-hole logging exception - No open-hole logs were run", and shall clearly identify the type of log and the well (byAPI#) in which open-hole logs were run.
