The operator of this production facility is Brooks Exploration. Our investigation indicates an Earthen Pit Permit has been issued to this facility by the Commission, with the condition of approval that the pit be lined.

There are indications in the file that bentonite was used by a previous operator in lining this pit. However, to ensure compliance in protecting groundwater we contacted Mr. Bill Brooks.

Mr. Brooks agreed to, and has in fact emplaced additional bentonite in the pit as insurance against groundwater contamination.

On June 25, 1993, the Environmental Protection Division of the Weld County Health Department received the following complaint:

Brinewater and other items being dumped in pond. The pond is located at 83rd Avenue, Greeley, 100 yards north of Poudre River, on the east side of the road. Legal description as follows: NW4, Section 32, Township 06 N, Range 66 W.

On June 29, 1993, I observed the above, alleged complaint. On this date, I observed what appeared to be a small (40' x 60') brinewater disposal pond. A sample was taken (results attached) which indicate that the fluid in the pond is likely brine.

The Division has determined that the authority for investigation and compliance enforcement in this case is under the Rules and Regulations promulgated under the Oil and Gas Conservation Act, as amended.

The Division requests that this complaint be investigated and the results of your investigation be forwarded to this Division and the property owner. In addition, please forward investigation reports of all similar situations in Weld County.
