TEP Rock Mountain LLC (TEP) requests permission to tie the bradenhead into the separator downstream of the choke on the Federal PA 423-23 well. A diagram for plumbing the bradenhead into the separator is attached. The bradenhead pressure is currently approximately 950 psi. This will allow the bradenhead pressure to equalize with our separator/line pressure which is currently at approximately 185 psi and protect the integrity of the surface shoe.
