COMMENTS:

TEP Rock Mountain LLC (TEP) requests permission to tie the Federal PA 314-23 bradenhead into a separator on pad. There are currently three wells on the Federal PA 31-26 pad needing bradenhead tie-in. These three bradenheads will be commingled at the wellheads inside the well cellar and run a single line to the tie-in point at the separator. This separator will only be used for bradenhead gas. A diagram for commingling the bradenheads and plumbing into the separator is attached. The bradenhead pressure is currently ~270 psi and steadily climbing. This will allow the bradenhead pressure to equalize with our sales line pressure which is currently ~180 psi and protect the integrity of the surface shoe.

Report results on operator’s annual spreadsheet and on a Form 17 if bradenhead test was performed, as specified in the Bradenhead NTO. 3)Comply with any CDPHE, Air Pollution Control Division rules or requirements for all atmospheric discharges. 4)Any liquids blown down are to be collected, stored, handled, and treated or disposed as E&P waste per COGCC’s 900 series rules. 5)At least one check valve is required for annular spaces that are tied to sales line or separator. Maintain equipment for pressure regulation and check valves in good working order.
