I, Inspector Mike Longworth, conducted a Follow Up inspection at TEP ROCKY MOUNTAIN LLC, PA-66S95W 32NESW, Location ID: 335325 in Garfield County, Colorado.

Location is in close proximity of Colorado River and creeks that run to the river in a High Priority Habitat Area. (Mule Deer Winter Concentration Area)

During this inspection the following possible compliance issues were observed to be unaddressed.

Unmarked deadmen.

Access road and location shows signs of lack of stabilization BMP's in some areas (rutting is present). Access road ditch needs maintained. Drainage ditch run up to access road has no evidence of culvert or passway to cross.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
