It appears Surface Owner is using site for storage. Cut and fill slopes have establishment of perennial vegetation, though infested with Noxious weeds, White top, Soctch, Musk & Bull thistle. Pad area has been revegetated also, though weedy, sparse, bare and compacted in portions. There is no Variance request on file for this Location.
