COGCC Records/GIS show this well and location is separate, and not associated with the adjacent "Vega Pad #4" location. COGCC Records also shows that the well shares facilities with the Pad #4.

Form 6(s) #401337066 indicates that this well existed to the north of the PR wells on the Vega Pad #4; Unable to find evidence of this well both on the Vega Pad #4, or at the coordinates listed under the well and location files.

It appears well should have been associated with the Vega Pad #4 Location (#334454), rather than the separte VEGA UNIT-69S93W 35NESW Location (#312431).
