This was a surface release that was initially scraped. Follow-up soil screening indicated that an isolated location had deeper impact. Excavation indicated that a small area of impact was deeper than the backhoe could excavate. BCEOC contracted a consultant to advance borings in the area (December 2017) and backfilled the excavation to allow for assessment. Borings indicate a likely separate source of historical impact coming from below (potentially from a former well, now P&A). We do not have anything besides anecdotal evidence to go on at this point.
