Comment:

It was observed in this inspection that Final Reclamation of the Location was not performed in accordance with Rule 1004.a.; Location and access road have not been decompacted, recontoured and reclaimed- Cut/fill slope remains evident, secondary containment berms remain evident, gravel has not been removed; surface equipment (pipe) remaining on northwest end of the Location; Vegetation on Location is predominantly Undesirable and Noxious Plant Species including, but not limited to, Field Bindweed, Redstem filaree, Hoary Cress, etc...

Well was abandoned 7/16/2016; pursuant to Rule 1004.a, final reclamation work was required to be completed by 7/16/2017.

Corrective Action:

Comply with 1004 rules and conduct final reclamation of the Location including by not limited to compaction alleviation, recontouring and revegetating; conduct weed management and continue to monitor/manage Undesirable and Noxious plants to prevent further spread and establishment. Weed management is required until site receives a passing final reclamation inspection.
