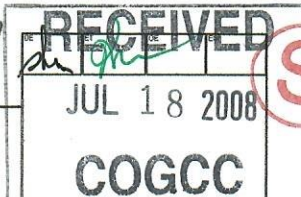

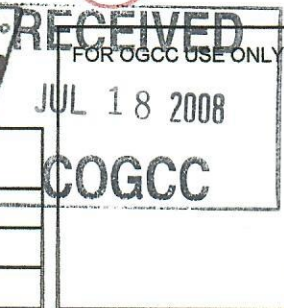

We applied a downhole pump and a string of rods, we put the well on line with a pumping unit and we started to sell gas.
