Comment: This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 06/07/2019. It does not appear any reclamation work has been performed; gravel remains throughout the location and access roads which have not been recontoured or regraded; weedy, annual vegetation was observed which includes but not limited to field bindweed and kochia. Refer to attached inspection photos.

Corrective Action:	Comply with Rule 1004. Operator shall perform compaction alleviation, recontouring and regrading, and reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.	Date	11/03/2022
