	<p>This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 12/02/2013. It appears operator has performed reclamation activities as there is no visible oil and gas equipment on locaiton and the access roads and location have been regraded and contoured to reflect reference areas. COGCC Staff observed a large area of annual weedy vegetation (e.g. russian thistle, kochia) on the location and access road, which appears to be slowing down progress towards final reclamation standards. Refer to attached inspection photos.</p>
