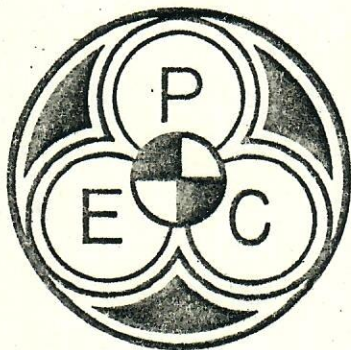

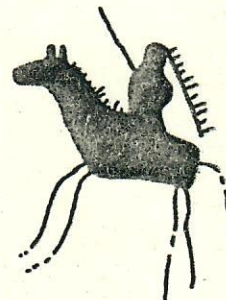


1. Abstract: A cultural resource survey for K & E Petroleum-LeClair Westwood, Miller USA #1, well pad and access, Logan County, Colorado; Canon City District Office Bureau of Land Management.

3. Project Description: well pad and access      Size: 20.4 acres - access

60.4 acres - total area surveyed  
Topography: The project is located in a rolling grassland terrain east of Pawnee National Grassland and dissected by Spring Creek, an intermittent tributary of the South Platte. Several large depressions collect residual runoff and support swarms of mosquitoes. The area is drained by Spring Creek, a meandering (cont.)  
Vegetation: Cover was estimated at 50% and ground visibility was good. The area supports a plains-grassland community of short grasses, prickly pear, yucca and minor quantities of thistle.
4. Examination Procedure: The cultural resource survey was performed on August 18, 1981, by Robert A. Williams and John Shimmin of Powers Elevation. The procedure consisted of parallel pedestrian transects at 15 meter intervals over the 40 acre primary and secondary impact easement. Approximately 0.5 mile of two-track dirt road and 1.2 miles of flagged right-of-way were surveyed in zig-zag transects to produce a 200 foot access corridor. A file search conducted with the (cont.)
5. Findings: No cultural resources were observed during the field investigation. Numerous coils of barbed wire were noted along the southern fence of Section 8, the remains of ongoing fence maintenance. These were apparently fairly recent (less than 20 years old) and were not recorded.
6. Recommendations:

We recommend no additions or amendments to the proposed K & E Petroleum-LeClair Westwood, Miller USA #1 well location and access. This recommendation is based on the absence of cultural resources in the 40 acre area and 1.7 miles of access.

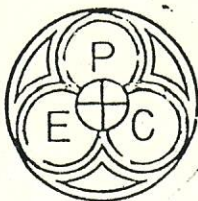

TOPOGRAPHY: intermittent dendritic stream which is the major erosional force in the area. Spring Creek was not flowing at the time of the investigation, but isolated pools were standing in several meanders. The soil is a silty loam-loess with some collected organic material in the depressions.

EXAMINATION PROCEDURE: Colorado Preservation Office on July 27, 1981, revealed no previously recorded cultural resources in the project area.

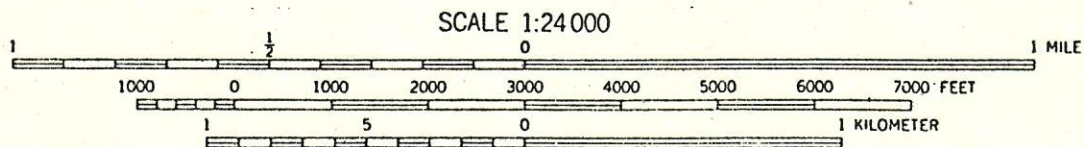
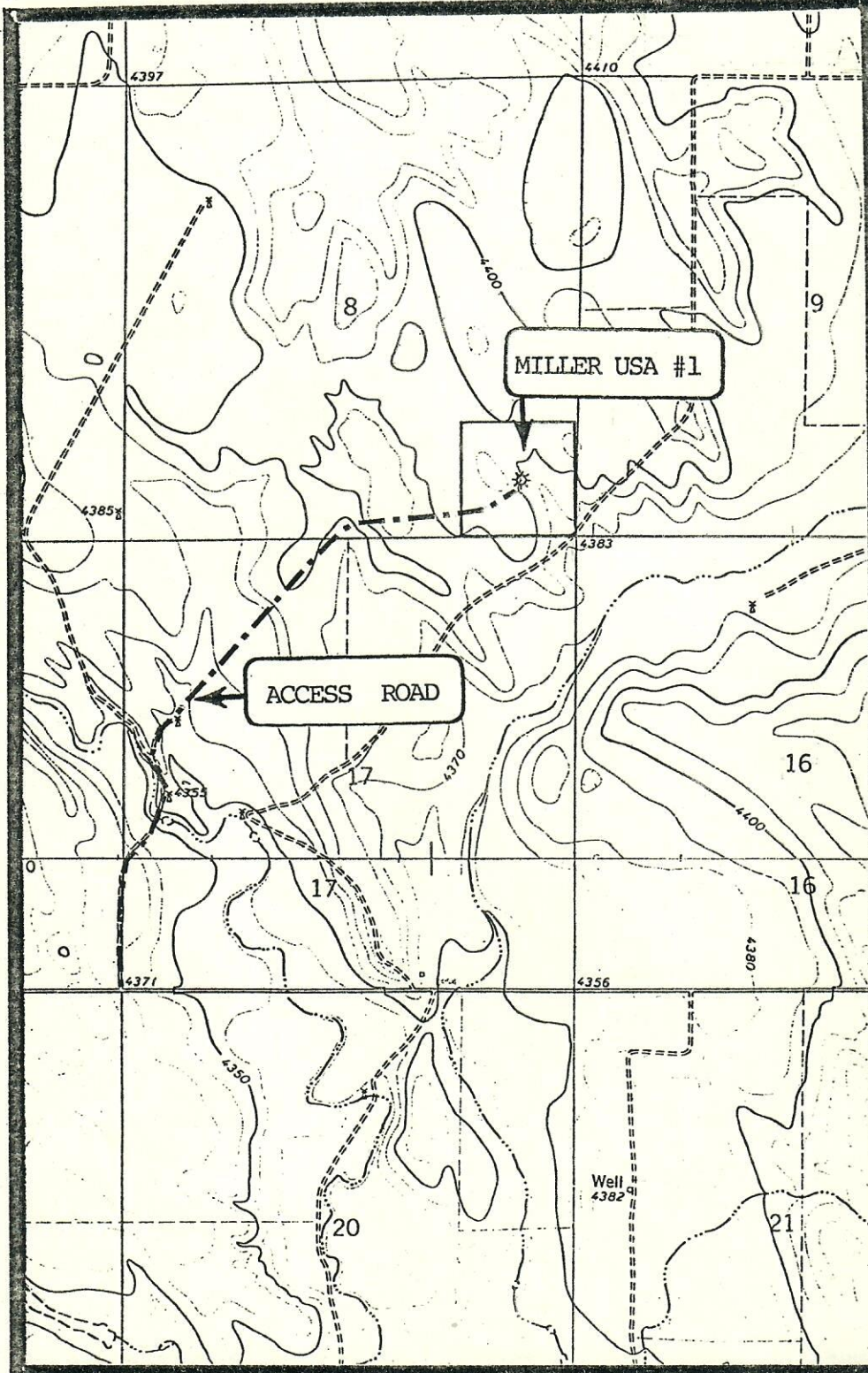




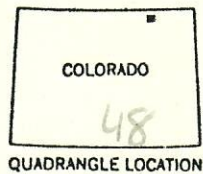
