The access road and location have not been reclaimed. There is gravel that remains along the road and the location has not been recontoured. There is erosion along the cut slope and the location is not stabilized and susceptible to further erosion. There is a pig launcher abandoned riser that remains approximately 1900' NW of the location. All equipment needs to be removed. The access road and location must be reclaimed per the 1004 Rules. The corrective action date is set for when final reclamation was required to be completed. Corrective action needs to be performed immediately to obtain compliance.
