Comment: Inspection #696204257 observed that off-location flowlines had not been registered. Inspection required Operator to comply with 1101.b and register off-location flowlines. Operator submitted Form 44 #403219324 on 11/10/2022; this satisfies the original corrective action.

It was observed in this inspection that COGCC Integrity Engineering Staff returned the Form 44 back to draft on 11/17/2022 with the following reason: "GIS data was in a subfolder, making the import fail. Data was reattached. File contains two flowlines, whereas the form has 13 lines. It is unclear whether 13 lines are in the trench or if just 2 are. Please modify form or GIS to reflect correct number of lines".

Document has not been resubmitted with the required corrections.

Inspection #696204257 observed interim areas of the Location that are not progressing towards 1003 standards. Inspection required Operator to conduct additional reclamation, and to implement BMPs to stabilize the seeded soils. Operator submitted Resolution #403217425 stating CA was completed.

Due to limited visibility from snow cover on the Location, Reclamation Specialist was unable to adequately inspect the interim areas of the Location. A followup inspection will be conducted in a future growing seasons to document compliance with 1003 requirements, and corrective actions.
