Based on the 909J sample for wells surrounding the Cliffhanger 21-28, which are producing from the same CBM formations, results show there are no detectable levels of Benzene, Toluene, Ethylbenzene, Xylenes (BTEX), Total Petroleum Hydrocarbons (TPH), Arsenic, Radium, or Volatile Organic Compounds (VOC's) above the RBSL standards in the water. With no organic compounds in the produced water which may be discharged into pit ID# 278928, there is no potential for volatile organic compounds (VOCs) emissions.
