A blower motor on one of the large volume tanks recently went out had to be replaced. To accomplish this task, the tank was pumped empty, and the bladder was deflated for a couple of days. While the tank was deflated, it snowed a few inches and snow melted inside the containment. Snow melt water came into contact with a small amount residue from an air flap on the top of the bladder. The residue and snow melt water were wholly contained within the secondary containment structure. The blower motor has since been replaced and the residue and snow melt water have been pumped out of the containment structure. TEP deployed a vac-truck and hot water to clean out the residue from inside the containment structure. The amount of residue that came into contact with the snow melt water was estimated to be less than 1 bbl and did not exceed any of the reporting thresholds per Rule 912.b, therefore, this was not a reportable release.
