Comment:

This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 03/18/2013. At the time of this inspection, Staff observed that bare soil and debris remain on location; this was also documented in inspections #682504409, #69200044, and #696200381. Additionally, Colorado List C Noxious Weed (e.g. cheatgrass) and other undesirable species (e.g. kochia) were observed to be growing throughout the location and will need to be managed for. This location does not appear to be progressing towards Rule 1004 standards. Refer to attached inspection photos.

Corrective Action:

Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Corrective action date is the date the location was observed out of compliance.
