General Comment:**COGCC Inspection Report Summary**

On Thursday 6/15/2023, I, Inspector Scott Ramsey, conducted a routine inspection on site at Beaman Jones 1-11, at Location # 316760 in Route county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed pump jack not in operation but could hear fluid going into tank. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife black bear Management and Density habitat.

I witnessed fresh gravel covering stained soils. Stained material has not been removed and disposed of properly.

During this inspection the following possible compliance issues were observed:

1. Random debris and unused equipment
2. Pump jack is missing guard
3. Multiple stains
4. 2 tanks are lacking signage
5. Propane tank is lacking proper labeling
6. Weeds throughout location and around production equipment also in secondary containments.
7. Open hole on separator for wildlife to enter
8. Open hole with piping for wildlife or personal to fall into.
9. Venting from top of tanks (images taken with OGI)

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
