**General Comment:****COGCC Inspection Report Summary**

On Thursday 6/22/2023, I, Inspector Scott Ramsey, conducted a routine inspection at TEP Specialty 41A, at Location # 335080 in Garfield county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.

C/A (Stored equipment (ECD disconnected) from previous inspection are still present form DOCUMENT # 700704704 Therefore C/A date remains the same 12/26/22. C/A's (Lack of stabilization and valves on tanks missing plugs) have been addressed.

Location is within or close proximity to CDPHE air pollutant emissions inventory.

During this inspection the following compliance issues were observed:

1. Meter calibration card not conspicuously posted.
  2. Tank label falling off.
  3. Stored equipment (ECD is disconnected)
  4. Venting tank. Video taken with FLIR camera.
