Comment: At the time of this inspection, there was observed stormwater erosion along the western edge of the tank battery. It appears stormwater is draining from higher areas through the tank battery causing channelized flow and rills that are causing sediment runoff.

Corrective Action: Comply with Rule 1002.f. Install or repair required BMPs per Rule 1002.f. BMP's shall be maintained until the facility is abandoned and final reclamation is achieved pursuant to rule 1004.
