<p>Comment: Previous inspection observed that stormwater management on the Location and access road is inadequate: BMPs to minimize erosion, degradation and off-site sediment transport are missing or insufficient on the Location and access road. Runoff is resulting in gully erosion within ruts of the road; runoff and stabilization controls at Location/road inadequate. Cut slopes lack stabilization. Inspection required Operator to comply with Rule 1002.f.</p> <p>It was observed in this inspection that stormwater management on the Location remains inadequate; erosion degradation on the Location and access road has persisted. Unable to find evidence that corrective actions have been taken by Operator to address the compliance issues.</p> <p>Corrective Action: Comply with Rule 1002.f. Install or repair required stormwater and erosion control BMPs at the Location and access road; temporary controls required until final reclamation work is performed, at which time additional BMPs will be required until long-term stabilization (such as revegetation) of the disturbances have been achieved. BMPs are required to be installed in accordance with Good Engineering Practices, and maintained in proper functioning condition at all times.</p> <p>Stormwater management required until final reclamation is achieved pursuant to 1004 Rules.</p> <p>Date: 04/26/2023</p>

<p>RECLAMATION COMMENT</p> <p>All Form 2 and Federal "permits to drill" on file for the Location have expired; Form 2 #400473181 expired 4/10/2016, Federal APD (doc. no 1828348) expired 7/31/2010.</p> <p>Previous inspections observed that the Location has been constructed, and various surface equipment (pipe, risers, cellars) have been installed at the Location and along the access road; no wells have been drilled; work to maintain the Location and access road has not occurred. Location subject to Final Reclamation Requirements; inspections required Operator to comply with Rule 1004.a by 9/15/2022.</p> <p>It was observed in this inspection that final reclamation of the Location and access road has not been conducted; Location/Access road has not been decompacted, recontoured/reggraded and reclaimed. Surface equipment along the road/Location has not been removed. Culverts along the access road remain, drainages have not been restored; Access road has continued to degrade.</p> <p>Original corrective action and date remains applicable: Submission of additional permits does not waive compliance with 1004 requirements- See "Notice to Operators: Interim Reclamation Procedures for Delayed Operations" dated January 5, 2017.</p>	trujilloam	08/15/2023
