Rule 606. 8/22/23</p> <p>No wellhead signs. Rule 605 .a. 9/15/23</p> <p>Bradenhead access. Rule 419.a(1), (2). 8/25/23</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with ECMC rules.</p> <p>Spoke with company representative at time of inspection and they informed me that wellhead signs would be ordered and installed by tomorrow, and temporary signes would be created until permanant signs are created. Company representative also informed me that all bradenheads would be plumbed to surface by roustabout crew in the morning. Company representative also removed unused chemical tanks, and informed me they would use temporary control measures in order to compy with rules.
