General Comment:**ECMC Inspection Report Summary**

On Thursday, 08/31/2023, Inspector Kirby Burchett, conducted a routine field inspection at TEP Rocky Mountain LLC on the Federal 298-25-1 well, Location #315565, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District with Black Bear, High Priority, NSO, and Density Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

While there during normal operations the following compliance issues were observed:

1. PVC tube open to wildlife
 2. Tank capacity missing from tank labels
 3. Well is overdue for Mechanical Integrity Test to maintain TA status
- Refer to Inspection Photos for observed compliance issues.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with ECMC rules.
