Comment: The location has recently been mowed for weed control. The desirable vegetation does not appear to be progressing and the location consist of mostly undesirable weeds. There are bare areas with no vegetation which appears to be impacted soils. Operator will need to investigate and sample impacted soils per Rule 913. The location will need to be reseeded to establish a uniform vegetation cover. Continue to monitor and maintain the location until the final reclamation requirements are achieved.
