During this inspection, it was observed that several Colorado Noxious weeds (List B: Canada thistle, Common teasel and Russian olive) were observed throughout the tank battery location. Noxious weeds have already seeded out and will require management/eradication during the next growing season. Refer to attached inspection photos.
