During this inspection the following compliance issues were observed:

1. Signs/Marker - Condensate tank label weathered & illegible with a CA date of 01/06/2024
2. Housekeeping - Multiple places with stained soils and gravel on location with a CA date of 12/17/2023

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
