1-14-92	10 hours	Moved rig on well. Raised mast and poles. Checked in to 1000'. Mud in casing.
1-16-92	12 hours	Dug cellar. Had to cut off top of head.
1-17-92	9 hours	Had pit and deadmen dug. Ran 2 3/8" tubing to 4800'. Backhoe, 4 hours.
1-20-92	11 hours	Pumped 200 bbls. water out of 2 3/8" to wash mud out of casing. Pumped 15 sacks cement at 4800'. Pulled tubing. Set in jacks. Worked pipe to 10". Water truck, 5 hours. Pump job.
1-21-92	11 hours	Worked pipe to 18". Hooked up staff. Pumped water down casing. Found hole at 3900'. Water truck, 3 hours.
1-22-92	12 hours	Worked pipe to 28". Shot at 3600'. Worked pipe loose. Pulled 10 joints.
1-23-92	6 hours	Pulled 80 joints casing.
1-27-92	11 hours	Pulled 26 joints casing. Pumped 35 sacks cement half in and half out bottom of surface. Pulled rest of 5½". Pumped 10 sacks cement in top. Cut off surface down 4'. Welded on cap. Tallied pipe.
