This location is within or in close proximity to a Parks and Wildlife (CPW) District and Wildlife Management Plan with Black Bear, High Priority, NSO, and Density Habitat regulations.

While there during normal operations the following compliance issues were observed:

1. Random debris
2. No sign at tank battery.
3. Location is behind locked gate. No sign at entrance.
