While there, I observed a plugged and abandoned wellhead. During this inspection the following possible compliance issues were observed: 1. According to the well file, this wellhead was plugged and abandoned on 10/23/23. The Operator has 90 days after the cut and cap date to remove all equipment from the location; February 5, 2024 has exceeded that 90 day window. Remove all equipment per Rule 603m. (Corrective Action Date: February 12, 2024) See attached photo #2.</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
