<p>COGCC Inspection Report Summary</p> <p>WEATHER CONDITIONS: sunny, dry ground.</p> <p>On Tuesday, March 5, 2024 at approximately 1045, I, Inspector Brittani Santistevan, conducted an on-site inspection at BARNARD 4-23 (Noble Energy, Inc.), at location ID: 330172 in WELD COUNTY, Colorado.</p> <p>While there, I observed a temporarily abandoned wellhead.</p> <p>During this inspection the following possible compliance issues were observed:</p> <p>1. It appears that there is an unused gas meter and riser on location. All other equipment from tank battery has been removed. Comply with Rule 606. (Corrective Action Date: April 5, 2024) See attached photo #2.</p> <p>2. The fencing surrounding the wellhead appears to be damaged. Repair to comply with Rule 603.h. (Corrective Action Date: April 5, 2024) See attached photo #3 - 5.</p> <p>3. It appears there is no wellhead sign displayed. Install signage to comply with Rule 605 d. (Corrective action Date: April 5, 2024) See attached photo #3 – 5.</p> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
